You are invited to take part in this research survey, YourGround NSW – a collaborative project between CrowdSpot and Monash University. The survey will be conducted through an online platform that can be accessed via the YourGround NSW website from any device and will take approximately 10 minutes.

This Explanatory Statement is being provided to you to allow you to decide whether or not to participate in the research. Please read the Explanatory Statement carefully. If you would like further information regarding any aspect of this project, you are encouraged to speak to the researcher. You can contact the researcher via the phone number or email address above. Feel free to ask any questions about any information in the statement.

Once you understand what the project is about and if you agree to take part, you will be asked to provide consent electronically by selecting “Agree” via the digital Consent Form pop-up box on the landing page of the YourGround NSW website. Clicking on the ‘Agree’ button indicates that you acknowledge and agree that:

You have read the information outlined in this Explanatory Statement.

You voluntarily agree to participate in the study.

You are 18 years of age or older (if you are under 18 you must be supervised by an adult).

You understand that you are free to end the questionnaire at any time. However, once the survey is submitted you cannot withdraw your response

By selecting “Agree” to the items on the Consent Form, you indicate that you understand the information and that you give your consent to participate in the research project. You may print a copy of this Explanatory Statement to keep as a record.

### **What does the research involve?**

This research survey is designed to explore the experiences of women and gender-diverse people when engaging in public space. The research will:

1. Examine the experiences of women and gender diverse people while using public space;
2. Understand how these experiences are informed by public space design and infrastructure;
3. Analyse the typologies and relationship between safe and unsafe experiences for different demographics in public spaces.

The research aims to inform a larger body of research around gender and public space. It investigates the environmental features that encourage women to interact with public space and how it varies across cultures and contexts of NSW. The survey will be conducted across the whole state of NSW, to understand how safe and unsafe experiences affect and shape women’s use of public space. The survey is open to anyone over 18 years. Any person under the age of 18 will need to check with a parent or guardian before submitting a response.

The outcomes of this research will be used for:

- The prioritisation of the needs of women and gender-diverse people in their communities through strategy and budget
- Awareness building around gender issues in their communities
- Showing their active and positive engagement with the health and wellbeing of women and gender-diverse people in their communities.

This research has received funding from the New South Wales state government Department of Communities and Justice. The raw data resulting from the survey will be shared with the NSW State Government Partner. The data resulting from the survey will be analysed and included in a report delivered to the NSW State Government Partner. It will inform future research into this topic, be included in future publications, and possibly public talks and workshops.

In the survey, you will be asked to add a geolocated pin or 'spot' via an interactive map and answer a series of questions. Pinning a spot is easy and could take less than a couple of minutes, but this depends on how much detail you wish to give. You can pin as many spots as you wish.

As a participant, you will be asked to provide insight and feedback on the topic. Data will be collected through this survey. Then the data will be incorporated into the final report. The survey is anonymous. It will not be possible to withdraw your data once it is submitted.

### **Consenting to participate in the project and withdrawing from the research**

By consenting to participate in the survey as a research participant, you are consenting to allow us to use the information obtained in the survey as data for this research project. You will remain anonymous. Once you have submitted the data, withdrawal from the study is not possible.

### **Possible benefits and risks to participants**

By participating in this study, you can contribute your thoughts and experience of public space. This is an opportunity to reflect on your experiences of public space and how it affects your feelings of safety. It is also an opportunity to contribute your knowledge and experience to improve the future experience of women and gender diverse communities in public space.

The survey is designed to help participants share experiences and concerns about this topic. However, for some people answering questions about a negative experience in public space can be upsetting and confronting. All entries will be moderated to ensure that identifiable data, abusive comments, trolling and other inappropriate matters are removed before contributions are visible on the map. There are no other perceived risks involved with any other aspect of this project. If you no longer wish to participate in this study, you can leave the survey at any time prior to submitting and no data will be collected. Collected information will be collated and presented in de-identified and summarised research reports.

### **Confidentiality**

Your participation is confidential and, as the survey is anonymous, participants' names, responses and reflections cannot be disclosed or published in relation to what they share in the survey.

### **Results**

Results of this research will be included in a report to the NSW State Government Partner. Participants are given the option to provide their email address, which will be used to share a link to the report once the report is released. Some results may be made available through published written work, public forums and discussion and future workshops related to this research.

### **Storage of data**

Research data will be retained in accordance with the Australian Code for the Responsible Conduct of Research (2007) and Monash University's Research Data Management Policy. Only the Director of CrowdSpot will be able to access the administrative dashboard to access the data collected from submission.

Digital data from the survey will be stored on Google Drive and backed up on the Monash University share drive (S Drive), which is secure, centrally managed, reliable, and backed up.

The director of XYX Lab will only have access to the de-identified data once it has been exported from the Dashboard.

CrowdSpot will be complying with the University's Privacy Policy to ensure that all reasonable standards are adhered to ensure that information is protected from misuse, loss and unauthorised access, modification or disclosure. The research data (i.e. the raw information collected) will be kept securely at Monash and CrowdSpot for 5 years after collection, before being destroyed whereas the final report will remain archived in hard copy.

If the data is no longer needed after completion of the research, it will be disposed of in the following ways:

- Digital data (i.e. electronic copies of survey responses) will be destroyed by deleting or overwriting information or destroying the physical media.
- Data stored in cloud services shall be made unavailable by using methods such as Crypto-Shredding.
